

Chronic Obstructive Pulmonary Diseases: Journal of the COPD Foundation (JCOPDF) Reprint Options, Policies and Agreement

While the *JCOPDF* is an open access journal and free access to its content is encouraged, reproduction of *JCOPDF* content for bulk commercial distribution and use must be approved by and purchased from the COPD Foundation, sole copyright holder of all *JCOPDF* content. This includes the posting on commercial sites or the commercial distribution of web links to any *JCOPDF* content and bulk downloads of *JCOPDF* content pdfs. (Authors should contact the Foundation directly related to their requests for personal use of articles, figures, charts, etc.)

Formats of Reprints Available for Purchase:

- **Paper reprints** are available in either black and white or color options. Reprints are shipped to the purchaser at standard shipping costs rates.
- **E-prints**, an electronic alternative, are available for purchase as well. An e-print is an electronic version of the article (in PDF format) that can be provided to the purchaser for dissemination via email. The e-print will have a special disclaimer confirming permission to distribute.

Customization:

- The article's issue cover may be added to the article reprint for an additional cost.
- Branding statements ("Compliments of xxx," or "Provided by xxx,") and/or inventory "codes" may be added to the *back* of the reprint (by the *JCOPDF*, at the customer's request, at the time of the reprint order) for an additional cost.
- Customers' legally required product disclaimers may also be printed on the reprint as needed.

Reprint Policies

By signing below, purchasers agree to the following policies and restrictions:

- *JCOPDF* article content cannot be altered, excerpted or added to. Specifically, graphics, trademarks, logos, advertised products or product symbols may not be added to the reprint's cover or within the article. No additional text may be printed directly onto the text pages except that which is created and printed by the *JCOPDF*, such as the branding statement and inventory codes, as mentioned in the Customization section. This customization must be done by the *JCOPDF* (and only the *JCOPDF*) at the time of the reprint order. This includes but is not limited to rubber stamping or adhesive stickers—these are also not permitted.
- *JCOPDF* reprints may not be bound or included within other materials such as promotional sales pieces, product descriptions or any other type of materials. In addition, any email used to distribute purchased e-prints may not interpret, summarize or provide opinion on the e-print article.
- The reprint must be a freestanding piece—not physically attached to anything such as advertising materials OR have anything physically attached to it, such as product samples.
- The COPD Foundation will include a statement granting permission /approval for distribution of the reprint to the purchaser.
- **Reprints are only available for articles that have been published in a final, numbered issue of** *the JCOPDF***.** Articles posted in the "In Press" section will not be available for reprint purchase until they have appeared in a regular issue.
- E-prints will be limited to the number of e-prints purchased, as stipulated in the order details below, and the language of the email used to distribute the e-prints must be reviewed/approved by JCOPDF prior to distribution.
